U.S. FEDERAL AND N.C. STATE INCOME TAX FILING REQUIREMENTS

January 1st through April 15th is "Tax Season" in the U.S. During this period, U.S. citizens, permanent residents and non-resident aliens must file income tax returns and other tax forms. *Every individual present in the U.S. during the previous year in F-1, F-2, J-1 or J-2 immigration status must file certain tax forms, even if they have not worked in the United States.* ALL international students, scholars and their dependents (F-1, F-2, J-1 and J-2) must file Internal Revenue Service (IRS) tax Form 8843. **Most nonimmigrants who worked and earned income in the U.S.** in the previous year must **file income tax returns AND Form 8843 on or** *before Monday, April 15th, 2019.* Those who worked in the state of North Carolina during the previous year may be responsible for filing a N.C. state income tax return as well as a U.S. federal return. *Please note that there have been several important changes to US tax law since the 2017 tax filing season.* Some publications have not yet been updated to include these changes. Be sure the tax form instructions are for the 2018 tax year and pay close attention to the "What's New" section of the instructions.

The following information is intended for individuals in nonimmigrant status who will file as *nonresident for tax purposes*. Please consult <u>IRS Publication 519 "U.S. Tax Guide for Aliens"</u> to determine whether to file as Nonresident or Resident for income tax purposes. Some nonimmigrants may be eligible for a reduction in taxes due to a treaty between the U.S. and their country. Refer to <u>IRS Publication 901 "U.S. Tax Treaties"</u> for more information. **Even if exempt from taxes due to a treaty, tax forms must be filed with the IRS.**

UNC Law VITA Tax Sessions for International Students and Scholars*

UNC Law Volunteer Income Tax Assistance (VITA) program will provide two information sessions to international students and scholars on tax preparation services available through VITA, how to sign up for an appointment, and documents needed for your VITA appointment. Tax Sessions for Individuals Filing as NONRESIDENT for TAX PURPOSES*

A volunteer from the local community, Ms. Margaret Hung, will give a brief overview of filing requirements and relevant U.S. Federal and State of North Carolina tax forms, followed by a Question & Answer period. Each session will cover the same material, so you will only need to attend one.

- Monday, February 18, 5:30-7:00pm (FedEx Global Education Center, Nelson Mandela Auditorium)
- Monday, April 1, 4:30-6:00pm (FedEx Global Education Center, Room 1005)

Please note that students and scholars attending the sessions should bring their tax documents (W-2, 1099, 1042S and/or other statements of income), along with tax forms (downloaded from www.irs.gov), and prepared questions.

*These sessions provide general information and will not provide one-on-one tax counseling. Individuals with complicated tax situations may find it beneficial to attend the tax workshop to get started, but it may also be necessary to seek additional help from a tax professional.

Volunteer Income Tax Assistance (VITA)

Low-Cost Tax Preparation Program by State Employees' Credit Union (SECU)

State Employees' Credit Union (SECU) provides low-cost tax return (\$75) preparation assistance for Credit Union members. You must be a member to qualify and this service is provided by appointment only. Preparers will review your documents to determine if they can assist in filing your return.
